## Terms & Conditions

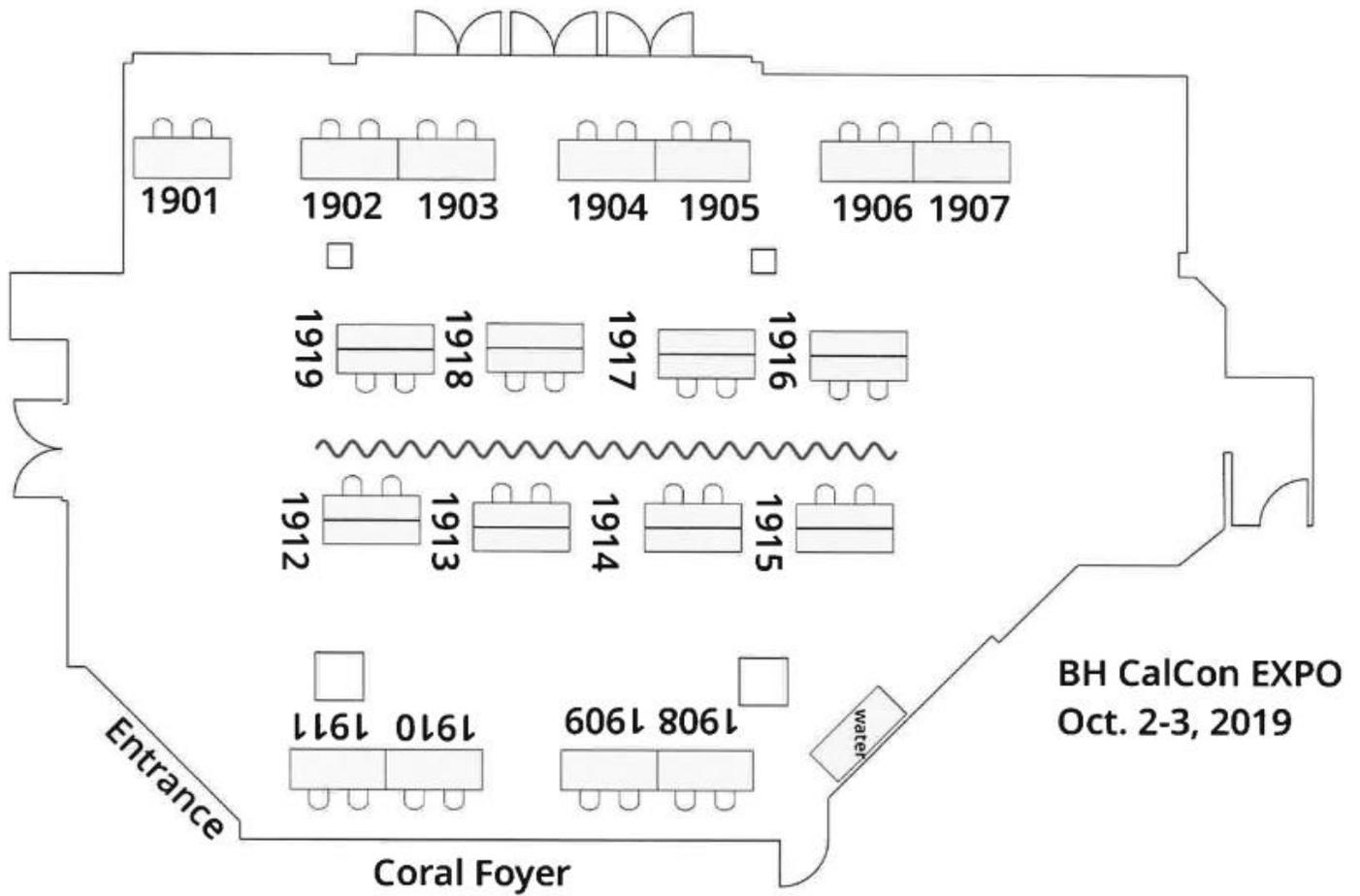
